Social Security Announces 3.6% Cost of Living Increase

Social Security has announced that beneficiaries (including SSI recipients) will receive a 3.6% cost of living (COLA) increase in 2012. The press release from SSA is attached. Any changes to Medicare premiums for 2012 will be released shortly.

One 5-Star Plan for Massachusetts in 2012

CMS has released the 5-star quality ratings. Only one Massachusetts plan has earned the 5-star rating for 2012—Health New England's MA-PD plan, available in Hampden, Hampshire, and Franklin counties. If a plan has a 5-star rating, people with Medicare can use the new 5-star Special Enrollment Period (SEP) to enroll in that plan outside an enrollment period.

Nationwide, only thirteen plans received a 5-star rating:

- ◆ 9 Medicare Advantage health plans with prescription drug coverage
- ◆ 2 Medicare Advantage health plans
- ◆ 2 Prescription Drug Plans

CMS Consumer Alert

CMS has recently become aware of a website that has the appearance of being an official government website for the Pre-Existing Condition Insurance Plan. This new website - <http://preexistingconditioninsuranceplan.com> - is not maintained by any government programs and consumers are strongly urged not to submit any personal information requested by this website under the assumption that it is a government website. CMS is taking the appropriate steps to protect consumers from being misled.

New Preventive Benefits for Alcohol Misuse and Depression

CMS has announced two new preventive benefits available to Medicare Beneficiaries. The first is an annual alcohol misuse screening performed in a primary care setting. If the beneficiary screens positive for misuse, he/she is allotted up to 4 behavioral counseling sessions per year conducted by the primary care provider. The second benefit is an annual depression screening. Similarly, this screening must also be performed by a primary care provider. The full CMS decision memos for each benefit are attached.

MEDICARE ADVANTAGE & PRESCRIPTION DRUG PLANS

Blue Cross and Blue Shield Prescription Coverage at Walgreens

Walgreens will not be an in-network pharmacy provider for the BCBS Medicare Advantage plans effective January 1, 2012. Therefore, members of the Medicare HMO Blue PlusRx (HMO), Medicare HMO Blue ValueRx (HMO), and Medicare PPO Blue PlusRx (PPO) will have to pay 100% of their prescription costs if they use a Walgreens pharmacy. However, members of BCBS's Prescription Drug Plans—Blue MedicareRx Premier and Blue MedicareRx Value Plus—will still have prescription drug coverage at Walgreens.

Humana Outreach during Open Enrollment

Prescription Co-pays Increased for Commonwealth Care

Effective October 1, 2011, Commonwealth Care Plan Type I members had their prescription co-payments increased. These co-payments rose from \$3 to \$3.65.

Commonwealth Care Premium Billing Address Change

Starting in November, Commonwealth Care payments must be sent to a new Massachusetts address. Members are being notified by mail and email. To avoid delays in processing, members should make sure to send payments to the new address:

Members who use their banks' online bill pay services must change the Commonwealth Care address with their banks. Members who pay by EFT on MAhealthconnector.org or use the coupon and envelope provided don't need to do anything different.
