Pharmacy News Bulletin: Medicare's Limited Income NET Program – Low Income Subsidy requirement

NOTICE TO ALL PHARMACIES: Effective July 15, 2014 the Centers for Medicare & Medicaid Services (CMS) will require evidence of Low Income Subsidy (LIS) or "Extra Help" entitlement prior to point-of-sale facilitated enrollment into Medicare's Limited Income NET Program. When current program enrollment or LIS information exists within CMS systems, which is reflected in the E-1 eligibility query, claims will process without any additional action.
